PURSUANT TO SECTION 38.2-1812.2 OF THE CODE OF VIRGINIA, OUR AGENCY MAY CHARGE ADMINISTRATIVE FEES. OUR FEE SCHEDULE IS AS FOLLOWS:

COPIES / FAXES	\$ 75.00
PICK UP FEES	20% OF BOND PLUS EXPENSES
REPLACE INDEMNITOR	\$ 150.00
DISCHARGE OF LIABILITY	\$ 150.00
RETURN CHECK	\$ 50.00
SHOW CAUSE ISSUED AGAINST BONDING CO	20% OF BOND
ATTORNEY / INVESTIGATIVE	\$ 100.00 PER HOUR
RECORD RESEARCH	\$ 75.00
CREDIT FINANCE	18%
ALL CREDIT CARD TRANSACTIONS	5% OF BONDING FEE

IN ADDITION TO THE ABOVE FEES, THE FOLLOWING SHALL APPLY:

ADMINISTRATIVE FEES WILL BE CHARGED WHEN A SERVICE LISTED IS REQUIRED. FEES MAY BE CHANGED WITH A 30 DAY NOTICE TO INDEMNITOR AT THE STATED ADDRESS ON THE ACCOUNT. THE FEES ARE APPLICABLE FOR THE LIFE OF ANY BOND WRITTEN. THE AGENT IS ENTITLED TO RECEIVE A COMMISSION FROM THE BONDEE / INDEMNITOR FOR THE NEGOTIATING, WRITING, OR EFFECTING THE BOND ISSUED. I HAVE READ, RECEIVED, AND UNDERSTAND THE ADMINISTRATIVE FEE SCHEDULE. AS INDEMNITOR, I AGREE ITS MY RESPONSIBILITY TO ENSURE DEFENDANT'S COURT APPEARANCE AND THAT IF ANY FEE IS CHARGED, I AGREE TO PAY ANY / ALL FEES FOR SAID BOND, INCLUDING ATTORNEY'S FEES.
